 - Outside these hours, you should be at the evacuation site in the department effluent (09 254 05 89) to go or if not possible, by telephone to notify the operator of sulfuric acid (09 254 06 66-0498 90 51 57).
- Evac 2. Area effluent operator room**
- 24h/24h and 7d/7d accessible

WARNING SIGNAL



- EXERCISE EXTRA VIGILANCE;
- ORGANISEER YOURSELF TO EXPEDITE EVACUATION (LEAVE ENCLOSED AREAS, INTERRUPT WORK AT HEIGHTS, ETC.);
- PEOPLE AROUND AND ABOVE THE ROASTER, IMMEDIATELY NEED TO GO TO THE ROASTER CONTROL ROOM;
- AN ALARM TEST IS CARRIED OUT ON THE FIRST THURSDAY OF EVERY MONTH AT 12:00 HRS.

EVACUATION SIGNAL



- MOVE AWAY FROM THE HAZARD (FIRE, TOXIC CLOUD), IF POSSIBLE PERPENDICULAR TO THE WIND DIRECTION, AND GO TO THE NEAREST EVACUATION POINT;
- EVACUATE INDOORS;
- CLOSE WINDOWS AND DOORS AT THE EVACUATION POINT;
- TRANSMITTERS AT THE EVACUATION POINTS WILL INFORM YOU WHEN THE DANGER HAS PASSED.
